- 2. Follow-up from COOP on road conditioning & traffic flow SE corner Pawnee Rock. Frank Riedl, Dennis Neeland and John Falk of PR Branch were in attendance. They have been in contact with township road supervisor and have been working with him to get the county road and township roads back into shape. They have graded and hauled in sand & gravel, but know it is going to take some time to get the roads into really good shape. Have also provided the traffic signs for Shane Bowman to install. Mentioned that they will be unloading some of the bunkers soon so that there will be an increase in traffic again. Intend to inform drivers to stay off of Lindas Avenue and other inside roads, using only Center, County Road and Township Roads.

There was some discussion on adding better wording for Abatement/Assessment of Costs in sections 4-708 and 4-716 Violations i.e. "costs incurred by the city shall be charged against the lot or parcel of ground on which the nuisance was located."
