Call to Order - Mayor, Linda Waite

Roll Call – City Clerk, Sharon Anglemyer - Linda Waite Mayor and council members Deb Bader, Chris Mead, Paul Umble, Joyce Link Present. Phyllis Agee joined at 7:26pm.

**Motion #1** Deb Bader made a motion to accept the minutes of the June 3, 2019 meeting as written, seconded by Paul Umble. Carried 4/0.

**Motion #2** Deb Bader made a motion to accept the June 14, 2019 special meeting minutes as written, seconded by Joyce Link. Carried 3/0, Chris Mead abstained/ absent from meeting.

Vickie Dreiing with Adams, Brown, Baren and Ball presented the proposed budget for the year of 2020. The Council discussed the budget for fire and maintenance on page 7 wanting them both to be 20,000.00 for 2020, leaving 2019 as is. The budget hearing was set for August 5, 2019 at 6:30 prior to the council meeting. Vickie will get the proposed budget published in the Great Bend Tribune.

- 1. Insurance quotes, replacement or cash value. Discussion no changes.
- 2. Flag poles Chris Mead presented the idea of purchasing flags for the poles on Centre Street., starting with Welcome to Pawnee Rock flags. After discussion including the size that would work best it was decided to do more research and bring back to the August meeting.
- 3. Street Signs Deb Bader presented the estimate from Marks Signs for replacement street signs. After discussion of color the blue background with white lettering was preferred. Cost was also a concern not knowing what other expenses we could incur before year end. Consensus of council to table until next month.
- 4. Black Powder Association gathering in Pawnee Rock was tabled due to lack of information from them.
- 5. Noise Ordnance was presented by Deb Bader, she had 3 options to choose from. After discussion it was dropped due to lack of interest.
- 6. Historical Sign Jeremy at Marks Signs. This is for the installation of the Santa Fe Trail Pawnee Rock State Historic Site sign. Jeremy submitted a bid for \$1,560.00. If they pour the cement it would cost \$360.00. The council previously approved 1500.00 for this project.

- 2. Set Budget Hearing Meeting Date the council discussed a date for the Budget Meeting Hearing and decided on August 5, 2019 at 6:30 prior the Council Meeting at 7:00.
- 3. Barton County Public Health Emergency We received a Memorandum from Barton County Health Department asking us to allow them to come during a public health emergency/crisis to furnish them a POS (Point of Dispensing) location. After discussion it was the consensus of the council to allow this agreement. Sharon Anglemyer, City Clerk will return the signed agreement to them.
