# City Council Meeting Minutes Feb 1, 2016

1. Fire Truck-Deb Bader

3. Municipal Water Conservation Plan/KDHE

Clerk noted that the 334 Ordinance on Water Drought/ Emergency had been dropped off to the GB Tribune for publication and that Linda McCowan is working on re-typing the Municipal Water Conservation Plan for the city of Pawnee Rock with corrections of water usage, dates and rates charged . When it is completed it will be sent to KDHE as soon as possible.

4. Wayne Gore—water leak

City water meters were read on Dec 30 and Wayne's was found to have used 53 units of water. He was immediately notified by Shane Bowman and they could find no visible leak. Shane changed out the meter and Wayne had plumbers out and replaced the water line in its' entirety from meter to his house ASAP. Wayne is requesting Council give him some kind of relief from such a high water bill. Discussion by Council followed.
